

ORDINANCE NO. 60 OF 2014  
TOWN OF STONEWALL

TO AMEND AND REENACT SECTION 2 OF THE CODE OF ORDINANCES OF  
THE TOWN OF STONEWALL, RELATIVE TO MOTOR VEHICLES; TO PROVIDE  
FOR THE SPEED LIMIT ON CERTAIN STREETS.

Be it ordained by the Board of Council Members of the Town of Stonewall, Louisiana:

Section 2. Speed limits established.

B. The speed limit shall be 15 miles per hour on Church Street and Stonecreek Drive.

The speed limit shall be 25 miles per hour on the following streets:

The speed limit for all other streets shall be 35 miles per hour.

Upon motion of Council Member Nicholas Gasper seconded by Council Member Dot Simmons, the above and foregoing Ordinance was introduced on the 14<sup>th</sup> day of October 2014.

Motion to adopt the above and foregoing Ordinance 60-2014 was made by Council Member Nicholas Gasper. Seconded by Council Member Dot Simmons, whereupon the Ordinance was declared duly passed on the 11<sup>th</sup> day November 2014.


