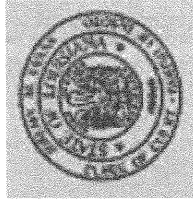

ORDINANCE NUMBER 98-2019

AN ORDINANCE TO ACCEPT THE STREET RIGHT-OF-WAYS AND SERVITUDES FOR UTILITIES AND DRAINAGE WITHIN CATHEY ACRES SUBDIVISION

BE IT ORDAINED BY the Council Members and the Mayor of the Town of Stonewall in regular session convened:

WHEREAS, the Town of Stonewall, DeSoto Parish, Louisiana has a duty to accept roads and street right-of-ways brought up to the Town of Stonewall specifications; and

WHEREAS, the Developer of Cathey Acres Subdivision has met these specifications; and

WHEREAS, the Developer of Cathey Acres Subdivision has submitted a final plat accepted by the Planning & Zoning Commission of the Town of Stonewall; and

WHEREAS, the Developer of Cathey Acres Subdivision has recorded a final plat with the DeSoto Parish Clerk of Court under Registry Number 757253 of the Conveyance Records of DeSoto Parish, Louisiana and dated January 22, 2019; and

WHEREAS, the Developer of Cathey Acres Subdivision will make a maintenance bond on twenty percent (20%) of the cost of the streets for a period of two (2) years; and

WHEREAS, the Town of Stonewall town engineering contractor has inspected and recommended the roads for acceptance into the Town of Stonewall road system.

NOW THEREFORE BE IT ORDAINED, that the Town of Stonewall hereby accepts the streets and right-of-ways for Diane Drive, Yopp Circle, AW Drive, Lori Drive, Merle Circle, Donna Drive and Wentz Drive of Cathey Acres Subdivision as more particularly described on the plat recorded under Registry Number 757253 of the Conveyance Records of DeSoto Parish, Louisiana.

First Reading having been read by title and introduced by Mayor Randal S. Rodgers at a regular convened Board of Council Meeting on Tuesday, June 11<sup>th</sup>, 2019.

Second Reading having been read by Mayor Randal S. Rodgers at a Public Hearing held on Tuesday, July 09<sup>th</sup>, 2019 at the Stonewall Municipal Complex.

UPON MOTION OF Council Member Crystal Walsh and seconded by Council Member Robert Baker was passed and adopted at the Stonewall Municipal Complex, Stonewall, DeSoto Parish, Louisiana, during a Public Hearing on this the 09<sup>th</sup> day of July 2019.


The Ordinance was adopted on Tuesday, July 09, 2019 at the Stonewall Municipal Complex and will go into effect on the 10<sup>th</sup> day of July 2019 with a vote as follows:


